Terms & Conditions as a Reseller of Globalstar Satellite Equipment, the following Terms and Conditions apply to all sales, rental and service agreements by Green Mountain Global

1. Payment and Sales Tax

Green Mountain Global accepts cash, certified checks wire transfers, and AMEX,VISA, MasterCard, Discover, for all purchases and services. Green Mountain Global charges sales tax on all shipments to Vermont destinations. Equipment is shipped subject to receipt of a completed and signed service agreement from the customer and credit approval. Based on its credit review, Green Mountain Global, as the service provider, may require a cash deposit and/or automatic credit card payment of monthly service and airtime.

2. All Sales are Final

As a standard practice, Green Mountain Global honors all manufacturers warranties and will assist customers in processing warranty claims, however all sales of equipment by Green Mountain Global are final.

3. Shipping

Green Mountain Global generally ships all orders within 24 hours of being placed, unless product is on back order, limited availability or special order status. Orders placed on weekends or holidays are shipped the following business day. (3a) Products are normally shipped using standard FEDEX Saver. Upon customer's request, and customer's expense, Green Mountain Global will expedite shipping via FEDEX P-1 or other means. (3b) Refused or undeliverable shipments will be subject to a restocking fee of 20% in addition to applicable shipping, transaction and insurance fees. (3c) Green Mountain Global does not ship to APO addresses or Post Office Boxes.

4. Back Orders

At Green Mountain Global, we continuously update our product listings to ensure the accuracy of inventory availability. When a product is listed as out of stock, your order will be automatically placed on back order. Green Mountain Global charges your credit card for the entire order amount. Items placed on back order are shipped as soon as they become available from the manufacture.

5. Limitation Of Liability

The services provided by Green Mountain Global may be temporarily interrupted, delayed or otherwise limited and is not available everywhere in the world. Green Mountain Global makes no representation that it can provide uninterrupted service.
